

Expectation Statement And Acknowledgement



I understand that if I win the title of the 2026 Poway Rodeo Queen or Jr. Queen title, it is my responsibility to be Poway Rodeo's representative and I am obligated to represent the sport of rodeo in its true light to the public. I will strive to exhibit excellent sportsmanship, high moral and ethical character and humane treatment of animals.

I will always strive to abide by the rules of the Poway Rodeo Queen Pageant, which are adapted from the Miss Rodeo America rules and regulations.

I understand that the Poway Rodeo Queen pageant is not a beauty pageant. The pageant is a competition which recognizes several attributes: horsemanship, personality, public speaking and interview skills. Therefore, it is my responsibility as Poway's representative to act, speak and dress accordingly. I will uphold the ideals my title deserves anytime that I am in the public eye or acting in the capacity of Poway Rodeo Queen or Poway Rodeo Jr. Queen.

If I am chosen as the Poway Rodeo Queen or Poway Rodeo Jr. Queen, I will:

Appear when asked by the Poway Rodeo Committee or the Poway Rodeo Queen Director to appear at events to promote the Poway Rodeo and the City of Poway.

Wear my sash, crown and proper western attire as outlined in the Rules and Regulations and by the Poway Rodeo Committee or the Queen Director whenever I make an appearance.

Uphold the title of Poway Rodeo Queen or Poway Rodeo Jr. Queen; encourage others to participate in future pageants, fulfill the provisions of my reign, act as a hostess to contestants in future pageants and assist in promotion of the pageant as requested.

I understand that all my appearances are to be approved by the Poway Rodeo Committee or the Queen Director. I agree to maintain close personal contact with the Queen Director and be available to all appearances requested.

I agree that during my reign, I shall observe a high standard of moral and ethical behavior befitting my title and will strive to set a good example to the public, to future competitors and the Poway Rodeo.

I understand and agree that all perpetual items (crown, chaps, loaned equipment or clothing etc.) are the property of Poway Rodeo Committee. These perpetual items are my responsibility to maintain, replace or repair them if damaged, lost or stolen.

I understand that ALL AWARDS received during the pageant are the property of Poway Rodeo Committee and will not officially be mine until my reign has been successfully completed.
